Base and body	Base on steel feet, 120 mm high with anti-oxidation plastic inserts, suitable for micrometric adjustable feet made of galvanized steel with plastic tip. Reinforcement ribs designed to accommodate the interlocking base. Body formed by single micro-joint paneling between roof and back to create slots for ventilation. Lateral sides with front thickness 30 mm and three-times refolded anti-cut edges.
Doors	Doors equipped with internal hinges with external pin with 180 ° rotation, reinforce on the hinges side and three times refolded anti-cut edges on the remaining sides, upper and lower ventilation slots, printed label holder.
